What is this product?

Туре

The SICAV is a Luxembourg Investment company subject to the provisions of Part I of the Law of 17 December 2010, relating to undertakings for collective investment in transferable securities (UCITS).

Term

There is no maturity date. The SICAV has been established for an unlimited period of time. Natam may terminate the SICAV and the Sub-Funds early, following the procedures described in §23 and §24 of the Prospectus.

Objectives

Investment objective The objective of the Sub-Fund is to achieve higher returns than euro bond market investing in debt instruments not in Euro currency and seeking capital appreciation also from the exchange rate performance.

Investment policies The Sub-Fund invests primarily in bonds, both fixed and floating rates, issued in currencies other than Euro by Government, Supranational and company issuers. At least 70% of the assets will be invested in securities with minimum rating A-Exposure to a single currency may not exceed 50% of the net assets unless the currency is other than USD, GBP, JPY,AUD and CAD in which case the percentage is limited to 25%.

Derivative instruments, which are financial contracts whose value depends on the market price of a reference asset, can also be used for investment purposes provided that the total commitment does not exceed, at any moment, 100% of the net asset value of the Sub-Fund; the investment in credit derivative instruments (i.e.Credit Default Swaps, Credit Spread Derivatives that allow two parties to exchange the credit risks specific to some issuers) is allowed only for hedging purposes.

The Sub-fund has been categorized as a financial product falling under the scope of Article 6 of the SFDR.

The Investment manager may use its discretion to invest in financial instruments not included in the benchmark in order to take advantage of specific investment opportunities. This active management approach involves a deviation from the reference index which can be significant.

The Sub-Fund is not intended to track the benchmark.

Redemption and Dealing Investors may redeem their shares on any business day for Luxembourg banks. They can also switch some or all their shares in those of another Sub-Fund and/or Class (with the exception of Class "L") within the SICAV without paying any extra fee.

Distribution Policy All income is, normally, reinvested.

Intended retail investor

This share class is suitable for Institutional investors only, having a medium-term investment horizon and with no preference for products complying with the ESG factors.

The information contained in this document is specific to Augustum Extra Euro High Quality Bond. However, the Prospectus, annual and half-yearly reports are prepared for the SICAV as a whole.

The SICAV consists of separate Sub-Funds with segregated liabilities. This means that the assets of a Sub-Fund will not be available to meet the claims of a creditor made against another Sub-Fund.

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This means that potential losses due to the future performance of the product are rated a medium-low level and that adverse market conditions are unlikely to affect the sub-fund's ability to return the initial capital.

Be aware of currency risk when your reference currency differs from that of the product. You might receive payments in a different currency, so the final return depends on the exchange rate applied.

This product does not include any protection from future market performance so you could lose part or all your investment. The significant risks not detected by the synthetic indicator, are detailed in the "Main risk factors" section of the relevant Sub-Fund Appendix of the Prospectus.

Performance scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable: this type of scenario occurred for an investment between November 2019 and November 2023.

Moderate: this type of scenario occurred for an investment between March 2016 and March 2020.

Favourable: this type of scenario occurred for an investment between January 2016 and January 2020.

What happens if NATAM Management Company S.A. is unable to pay out?

In the event of Natam's insolvency, the assets of the SICAV will not be affected. The assets of the SICAV are held in safekeeping by the Depositary, that is required by law to segregate its own assets from the assets of the Sicav.

If the fund is not able to pay you out what is due, you may lose your entire investment. Losses are not covered by an investor's compensation or guaranteed scheme.

What are the costs?

Costs over time

We have assumed:

Augustum Extra Euro High Quality Bond, a sub-fund of New Millennium Sicav - Class I Capitalisation EUR (LU0956013162)

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 4 years

The Recommended holding period (RHP) is 4 years but investors can request the redemption of their shares on any business day for Luxembourg banks without paying any redemption fee. The RHP has been selected on the basis of a quantitative and qualitive analysis considering the strategy, fees and risk profile of the product.

Please note that the expected return is, anyway, not guaranteed.
