What is this product?

Type

The SICAV is a Luxembourg Investment company subject to the provisions of Part I of the Law of 17 December 2010, relating to undertakings for collective investment in transferable securities (UCITS).

Term

There is no maturity date. The SICAV has been established for an unlimited period of time. Natam may terminate the SICAV and the Sub-Funds early, following the procedures described in §23 and §24 of the Prospectus.

Objectives

Investment objective The objective of the Sub-Fund is to achieve medium/long-term capital appreciation.

Investment policies Through discretionary choices, an active management and a flexible allocation the Sub Fund invests in the following asset classes:

- equity and equity linked securities - between 10% and 40% of the net assets
- debt securities between 10% and 90%. At least 10% is invested in Government or Corporate bonds with rating Investment grade. Up to 40% of the net assets may be invested in convertible bonds and CoCo bonds. ETCs up to 10% of the net assets, provided that they are classified as transferable securities
- cash and money market instruments
- UCITS and UCIs up to 10% including ETF classified as transferable securities
- derivative instruments, for both hedging and investment purposes with an expected leverage, calculated as a sum of notionals, not exceeding 300%. Investment in credit derivative instruments including credit default swaps and credit spread derivatives is allowed both for hedging the credit risk specific to some issuers present in the portfolio and for selling protections. Also Total Return Swaps are allowed.

Geographical preference is given to European area and exposure to emerging markets is limited to 25% of the net assets.

Exchange rate risk is limited to 25% thanks to the hedging activity of the main currency positions against the Euro.

The Sub-fund has been categorized as a financial product falling under the scope of Article 6 of the SFDR.

Target EURIBOR 3 MONTHS INDEX + 300 BPS

Target uses Discretion is allowed with respect to the target. The active approach, which characterizes the management of the fund, implies that the deviation from the target may be significant.

Redemption and Dealing Investors may redeem their shares on a weekly basis (as of each Friday). They can also switch some or all their shares in those of another Sub-Fund and/or Class within the SICAV (except share class "L") without paying any extra fee.

Distribution Policy All income is, normally, reinvested.

Intended retail investor

This share class is suitable for Institutional investors only, having a long-term investment horizon and with no preference for products complying with the ESG factors.

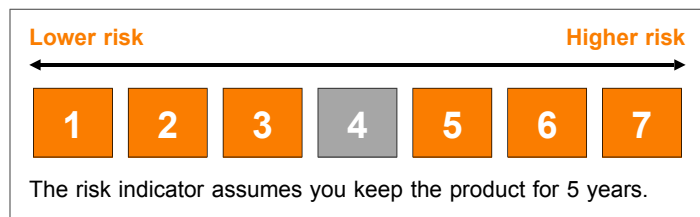

What are the risks and what could I get in return?

Risks

Performance scenarios

What happens if NATAM Management Company S.A. is unable to pay out?

In the event of Natam's insolvency, the assets of the SICAV will not be affected. The assets of the SICAV are held in safekeeping by the Depositary, that is required by law to segregate its own assets from the assets of the Sicav.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

The Recommended holding period (RHP) is 5 years but investors can request the redemption of their shares on a weekly basis (as of each Friday) without paying any redemption fee. The RHP has been selected on the basis of a quantitative and qualitative analysis considering the strategy, fees and the risk profile of the product.

Please note that the expected return is, anyway, not guaranteed.
